4.2 Entry Procedure

- Entries will only be accepted of classes stipulated in the NCR's,

4.3 Entry Fee

- Early entry fee Kshs. 12,000.00 per round of the championship
- Practice fee Kshs. 5,000.00 (payable on Friday)
- Entry will only be accepted with full entry fee.

4.4 Refund

Entry fee will be refunded in full:

- To candidates whose entry has not been accepted or kart not passing scrutineering.
- In case the event not taking place.

In any other case, refund of entry fee will be permitted only as per the NCRs 5.3.3

5.0 ADMINISTRATIVE CHECKS

5.1 Documents to be presented:

- Entrant's competition license
- Duly completed entry form (if emailed Original should be presented at Sign On)

6.0 SCRUTINEERING

Scrutineering will take place immediately after documentation. 0830 – 0930 Hours on 27th October 2019 late scrutineering on Sunday 28th October from 0700 – 0830 Hours only for those who were not scrutineered on 27th October 2019

- It's compulsory for a competitor to present Scrutineering sheet provided by the ASN.
- The Scrutineer may with guidance of C of C refuse start if the kart does not comply with safety standards.

8.0 PROTESTS

Final Results will be posted on the Event Notice Board as soon as possible after the Last Heat for a period of Thirty (30) minutes during which time any Protests must be lodged with the Clerk of the Course. Protests must be lodged in writing by a Competitor and must be accompanied by a Protest fee of Kshs: **10,000.00** in cash.

9.0 AWARDS/PRIZES

Awards/Prizes will be issued at the Discretion of KMSC, its **MANDATORY** to attend prize giving for all finishers, failure to do so will result in losing the championship points for this event.

Please make sure that you are signed on Saturday 27th October 2019 if you attend the practice. Signing-on for Sunday will only be allowed for competitors who will not have participated in practice the day before. Drivers entering on Sunday will be allowed practice as per schedule. Drivers must present their valid KMSF Licence, AMREF Maisha Flying Doctors card before allowed to sign on.
